- Great presentation – I like the presenter’s personal touch and awesome engagement skills and ability to help others engage.

Are there suggestions or improvements you would recommend for future meetings of this group?

- I would like to have more knowledge and training on: ACEs/TIC; How professionals can (or cannot legally) influence our local, state or national politicians regarding needs or solutions for families. (Write a letter to the editor, How to do a media interview, etc.); Learning more about how poverty affects us all; how media/screen time is affecting our kids and changing their brains – brain development in children. (Professional training by and for family training)
- Round tables are difficult to view the speaker/PowerPoint
- Very difficult to hear people at the table speak
- More in depth PD about engaging families and building leadership
- Having a variety of family engagement sectors involved to learn from each other, not just disability focused.
- Mix up the group so similar programs are not grouped together
- Shorter time span for sessions.
